Annual review of the 2022 KP submission - differences

Different from previous annual reviews: **Annex A** emissions (energy, IPPU, agriculture, waste):

- Emissions for 2020 (last year of CP2) are reviewed
- → reviewed emissions for the entire CP2 (2013-2020) available
- → last opportunity for recalculations (by Parties in their submissions and resubmissions) and, if needed, adjustments (during the review)



Annual review of the 2022 KP submission - differences

Different from previous annual reviews:

KP-LULUCF activities:

- Parties with CP accounting are reviewed and, for the first time, ERTs identify accounting problems. If not resolved, ERTs would adjust the estimates
 - Issuance/cancellation for the first time, for the entire period
- Parties with annual accounting: same as previous annual reviews → issuance/cancellation for the latest reviewed year (2020 in the 2022 review) taking into consideration recalculations for the complete time series

What is the True-up period for CP2 of the KP?

Decision 27/CMP.1, annex, section XIII

Parties may transfer to such Party, KP units (ERUs, CERs, AAUs and RMUs)..., until the hundredth day after the date set by the CMP for the completion of the expert review process ... provided that the eligibility of any such Party has not been suspended ...



True-up period and compliance with KP Art. 3.1 bis

Decision 13/CMP.1, annex, para. 14, in conjunction with 3/CMP.11

The assessment, after the expiration of the additional period for fulfilling commitments, of the compliance of a Party... shall be based on the comparison of the quantity of ERUs, CERs, AAUs and/or RMUs... retired by the Party..., with its aggregate anthropogenic carbon dioxide equivalent emissions... during the commitment period as... reviewed in accordance with Article 8, taking into account any adjustments..., as recorded in the compilation and accounting database

True-up period for CP2 – what will CMP 17 decide*?

Draft decision --/CMP.17

- 1. The expert review process for the last year of CP2 shall be completed by 1 June 2023 or by the publication date of the last review report, whichever is later

 Deadline expert review
- 2. Parties, review teams and Secretariat shall **expedite the review process** to satisfy this deadline

Preparatory work, continuous support

process and start TUP

3. Parties shall submit the true-up period report as soon as possible but not later than 45 days after the end of true-up period

Deadline TUP report by Parties

4. Secretariat shall prepare and publish **electronically** on 30 July 2023 and every four weeks thereafter, **information for each Party** on annual inventory data; total emissions for CP2; and total quantity of units held in Party accounts



True-up period for CP2 – what will happen in 2023–2024?

- If draft adopted, 1 June 2023 will be the end of KP reviews for CP2
- Approx. 2 months earlier than in CP1 (10 August)
- Is this **good**? **Probably so** (**if** it can be accomplished)
- For many years, most review reports (>80%) published by 1 June.
- ...but if one review report is pending, review process cannot finish
- Approx. 25 reviews in previous years, but approx.
 40 reviews expected in 2022 → higher workload
 → more experts needed → more support from
 Parties to their nominated experts
